#### 1. What aspect of student learning will you assess during this academic year?

The MPH Program will assess the degree to which students demonstrate public health skills and knowledge in professional settings during their fieldwork placement (Applied Practice Experience, or APEX).

### 2. Why have you chosen to assess this?

Assessment of public health skills and knowledge application in professional settings will demonstrate if students are meeting expectations of the current public health workforce and are prepared to enter the workforce. This information will help determine if modifications are needed to be made to our curriculum and instructional practices. The public health skills and knowledge we assess are directly relevant to the following Program Learning Objectives:

- Apply evidence-based principles to the process of program planning, development, budgeting, management, and evaluation in public health organizations and initiatives.
- Demonstrate leadership abilities as collaborators and coordinators of evidence based public health projects.
- Identify and apply ethical, moral, and legal principles in all aspects of public health practice.
- Develop public health programs and strategies responsive to the diverse cultural values and traditions of the communities being served.
- Effectively communicate public health messages to a variety of audiences from professionals to the general public

### 3. How will you assess this (i.e., describe your assessment methodology)?

The list of public health skills and knowledge included on the preceptor survey (Appendix A) were developed by faculty, preceptors, and advisory board members to be particularly salient in the current public health sector. Using the survey, preceptors will assess if students met or exceeded expectations of their preceptor on public health knowledge and skills. Assessment will be based on preceptor evaluation of student performance during their fieldwork hours and the products they created.

# 4. What is the timeline for data collection, analysis and review, and discussion of plans for indicated curricular or programmatic change(s)?

Students fulfill the 250-hour requirement of APEX hours during Fall and Spring semesters in the second year of the program. In Week 15 of Spring semester 2022, APEX instructors collect and review preceptor evaluations. While the preceptor survey is administered in Fall and Spring, we are focusing on results from the Spring survey when students will have completed their APEX projects and completed their 250 hours of fieldwork. The MPH Program Evaluation Committee (PEC) will collate scores across APEX sections, synthesize responses to the related open-ended question on the survey, and create a summary report in Summer 2022. The MPH PEC will discuss findings at one of their monthly meetings, then present findings at a program meeting or faculty retreat in Fall 2022. All faculty will discuss plans for curricular or programmatic changes. Findings will also be shared with the Associate Dean.
