### 11.13.2024

Beta phase 4: Thousands of additional students, parents and organizations are included to complete and submit their FAFSA.

### **By 12.1.2024** 2025-26 FAFSA officially releases!

### 10.1.2024

Beta testing phase begins. FAFSA is available to limited students, participating organizations, schools, and community groups.





### Preparing To Complete the 2025-26 FAFSA

- Create a <u>StudentAid.gov</u> account or Federal Student Aid ID (FSA ID).
- <u>Gather</u> information needed to complete the FAFSA.
- <u>Determine</u> who are the contributor(s) on your FAFSA.
- For dependent students, use the <u>Who's My FAFSA Parent? wizard tool</u> to determine which parent(s) will contribute their information.
- Stay informed and up-to-date about 2025-26 FAFSA changes and notifications:



### Federal Student Aid ID (FSA ID)


### What is a Federal Student Aid ID (FSA ID)?

- An account username and password used to log in to all Federal Student Aid products and tools on StudentAid.gov. All students and their parent and spouse contributor(s) will require a FSA ID.
- Parent and spouse contributor(s) without an SSN is also required to have an FSA ID. Additional verification will be needed.



### **Creating an FSA ID**

- Create an account at <u>https://studentaid.gov/fsa-id/create-account/</u>.
- 2. Provide your name, date of birth, and Social Security number (if applicable).
- 3. Enter a unique username, your email address, a strong password, mailing address, phone number, communication preference, and complete challenge questions and answers.
- 4. Confirm and verify your information.
- 5. Agree to terms and conditions.
- 6. Allow 3 days for your FSA ID to be verified





### FSA ID Without An SSN

- 1. Create an account on StudentAid.gov and complete all steps, including answering 1-4 knowledge-based questions via TransUnion.
- 2. Upon completion of the account creation process, the individual will see confirmation page of the results of their identity verification. If they failed the TransUnion process, the individual will be informed that FSA was unable to verify their information and that they must contact FSA Center.
- 3. FSA will create a case number and sends them a verification email, which will include guidance on how to submit copies of unexpired acceptable documentation to verify their identity. (i.e. U.S. Driver's License, state ID card, Foreign Passport)

### FSA ID Without An SSN (cont.)

- 4. Upon receipt of the email that FSA was unable to verify your identity, an individual is required to submit one or a combination of their acceptable documentation and sign attestation form.
- 5. FSA will review the submitted documentation and signed attestation form to ensure it is acceptable and matches the account information. If match is successful, the Department will finalize the account creation. The individual will receive an email that the account is ready to use.





### What if you forget your FSA ID?

- To reset your password, you will need to have access to the verified email, or verified phone number used when creating your FSA ID.
- How are you ensuring that you will have access to this information in the future?

### **Information Needed to Invite a Contributor**

The information required when inviting a contributor (student, independent student's spouse, or dependent student's parent) to complete the FAFSA includes the contributor's:

- Legal name (from their Social Security Card);
- Date of birth;
- Social Security Number (SSN) if they have one;
- Email Address





### 45 Day Deadline To Complete the FAFSA

- Students and all contributors should complete their portions of the application ASAP.
- Incomplete/saved applications will be deleted from the system after 45 days of inactivity or after the federal deadline date, whichever comes first.







The student is asked to provide consent and approval to transfer and use tax information from the IRS to the FAFSA.

Consent must be provided to be eligible for federal student aid.

### What about... Student and contributor who don't provide consent and approval

- Student and contributor has two opportunities to provide consent and approval prior to submitting the FAFSA.
- When consent and approval is not provided, a student aid index (SAI) will not be calculated and the student is ineligible for all student aid.
- Warning messages will appear regarding federal student aid ineligibility










### **Other Circumstances**

- This is another question that helps determine a student's dependency status.


### **Unusual Circumstances**



- The student is asked if any unusual circumstances prevents them from contacting their parent(s) or would pose a risk to the student if they are able to contact their parent(s).
- Some circumstances may be considered a homeless youth. Review the previous question to see if that applies.
- Contact the Financial Aid Office to determine next steps after submitting the FAFSA.



### **Your Dependency Status**



- Based on answers to the previous questions, the student is determined to either be a dependent or independent student.
- For dependent students, student have the option to apply for Direct Unsubsidized Loan only if parents are unwilling to provide their information.





- Once student and all contributor(s) have signed and submitted their portion of the FAFSA, the FAFSA is now complete!


