

SUMMARY ANNUAL REPORT

For University of San Francisco Defined Contribution Retirement Plan

This is a summary of the annual report for University of San Francisco Defined Contribution Retirement Plan, EIN 94-1156628, Plan No. 002, for period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$6,435,211. These expenses included \$59,467 in administrative expenses, \$6,257,927 in benefits paid to participants and beneficiaries, and \$117,817 in other expenses. A total of 3,028 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$243,163,719 as of December 31, 2016, compared to \$220,202,348 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$22,961,371. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$29,396,582, including employer contributions of \$14,149,346, earnings from investments of \$15,193,764, and other income of \$53,472.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

- Information on payments to service providers;
- Assets held for investment;
- Insurance information, including sales commissions paid by insurance carriers;
- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (University of San Francisco, 2130 Fulton Street, San Francisco, CA 94117) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
