International-by-Design: The University of San Francisco Master of Nonprofit Example 1: Administration has integrated international in global dimensions of nonprofit, philanthropy, NGOs and social enterprises into its curricular in program activities. Under the leadership of Dr. Marco Tavanti, the MNA Program in 2014 revised its curriculum to make the international dimensions of nonprofit, previously included in an elective course for NGO management, relevant to all other core courses. This has been possible through the integration of readings that compare and contrast NPOs/NGOs across legislative systems and cross-national countries. It has been possible thanks to the integration of faculty and international students who bring an international persecutive. It has been possible through the adoption of cases and projects that are relevant to not-US based communities. The Academic Global Immersion programs are optional for the degree completion but highly desired by our students who wants to gain knowledge of nonprofits, foundations, social cooperatives and international NGOs operating in the area of refugee service management, anti-human trafficking and forced migration. These options are integral part of three pre-post-in master level graduate certificates on sustainable development and sustainability reporting, nonprofit social entrepreneurship and innovation, and humanitarian emergency management.

Example 2: Experiential-by-Design: The University of San Francisco's MNA program has always regarded experiential education and professional relevance of its education since its early design in 1993. However, in the last 5 years, it has strategically and structurally integrated various experiential project-based learning into its curriculum. Benefitting from the rich content of nonprofit organizations in the San Francisco Bay Area, the Program has established various partnerships with nonprofits, foundations and community based organizations that recognized the benefits of university projects to improve their performances. Every course has some experiential elements from ED/CEO leadership interviews to marketing analyses and fundraising plans. Specifically, the required practicum and capstone courses have the project based learning

		integrated into their final projects in collaboration with and benefiting the capacity and effectiveness of partnering nonprofit organizations.
	Example 3:	While we follow closely the process of establishing more standardized metrics for social impact measurement in the social / nonprofit sector, the MNA program at USF has been investing in building our students and our organizational partner's capacity to measure and analyze their non-financial performances. We collaborate with innovative organizations and high-tech companies that provide platforms for identify proper indicators (e.g. SalesForce), align organizational performances with institutional priorities (e.g. through SDGfounders and the Foundation Center), and through dashboards and other tools that our students can apply into their organizations and projects (e.g. SoPact). Being in San Francisco we benefit from many innovative initiatives and technological developments that can lead the way for advancing and improving the measurement of nonprofit / third / social sector impact.
