### **MyISSS Student Portal**

The International Student and Scholar Services office (ISSS) will soon be transitioning to a new platform for students to view their immigration data and submit requests, **MyISSS Student Portal**. Our office is excited to provide this resource to our international student community. MyISSS Student Portal will allow students to submit requests to ISSS and view information and announcements from our office. Students will also be able to use this page to view the status of their current requests and view all past requests submitted through MyISSS Student Portal. Because of this transition, ISSS will have a brief pause in our ability to accept student requests. The last day we can accept requests through our **current online request system** will be on **Wednesday, May 6 at 5 p.m.** ISSS will resume accepting student requests via the MyISSS portal on **Monday, May 11 at 9 a.m.** 

You will receive more information by Monday, May 11 on how to access MyISSS. We are currently building information on our ISSS website that will provide students more information on how to engage with the MyISSS Student Portal system.

We are excited to provide students with a more interactive service and student portal experience. We know this will be a huge benefit to students once it is up and running, and we appreciate your patience during this transition period.

### **Program End Date Reminder**

ISSS would like to remind all F-1 students of their responsibility to complete their program on time. Remember that failure to complete your studies at USF before your I-20 program end date is considered a violation of your F-1 student status. Please note that the program end date listed on your I-20 also signifies the end of any student employment positions on campus.

If you will not be able to complete your degree requirements by the program end date on your I-20, please **schedule a Zoom appointment with your ISSS advisor** to discuss your eligibility for an extension of your stay in the United States. If you are eligible for an extension of your program, your complete **program extension request** must be submitted to the ISSS office **at least ten business days** prior to your I-20 program end date.

If you will be completing all the requirements for your USF degree by your I-20 program end date, congratulations! We hope you have enjoyed your studies at USF and we wish you the best of luck in your future endeavours.
