



WEEKLY UPDATE – Dec. 6

International Travel Considerations and Reminders

As you wrap up your fall courses, we are writing to make sure you have the most current travel information and feel confident in what you need for departing and re-entering the U.S. If you are already outside of the U.S. or decide to travel home this winter, please read the information below for guidance on what to expect and what documents you need. We recommend that you continue to review the **ISSS COVID-19 FAQ** for the most up-to-date information on these travel requirements for international students. You can also view USF campus policies related to COVID-19 on the **USF Together** web page, and specifically the **travel page** for USF's travel policies. TRAVEL CONSIDERATIONS

When planning for your return to the U.S. you will want to consider flight, travel, and entry restrictions.

Guidance for Air Travelers: The U.S. will require all individuals traveling **on or after Nov. 8th to be vaccinated against COVID-19**. All WHO or US-FDA approved vaccines will be accepted. View **acceptable vaccination documentation** here and keep it accessible at all times when traveling. There will be some exceptions to the vaccination requirement for youth under 18, those with medical conditions, and those traveling from countries where vaccines are limited. The vaccination requirement will replace the regional travel restrictions. Per the **CDC requirements** air travelers who plan to enter the U.S. must also provide a negative COVID-19 test to their airline in order to board their flight. U.S. Entry Restrictions: During the pandemic, the U.S. has implemented travel restrictions for certain countries. However, as of Nov. 8th, 2021 the travel restrictions were replaced with proof of vaccination. Due to the subsequent outbreak of a new COVID variant in southern Africa, the U.S. implemented another round of restrictions on 7 countries in the southern part of Africa (Botswana, Eswatini, Lesotho, Malawi, Mozambique, Namibia, South Africa, and Zimbabwe). Foreign nationals traveling from one of these countries to the U.S. will need to quarantine in a third country for 14 days.

DOCUMENTS NEEDED FOR TRAVEL

Do you Have a Valid Travel Signature on your Most Recent I-20? Before you request a new travel signature, be sure to log into your **MyISSS account** and view your most recent I-20. Note that travel signatures can be found on page 2 of your I-20 and they are valid for one year from issuance (six months for students on OPT). If you already have an I-20 with a valid travel signature in your MyISSS account, you can return to your record, download, print and sign this document. Students are issued new I-20s for many request types including CPT, OPT, and Reduced Course Load. Please review all of the requests in your profile to find your most recent I-20. Reference the **MyISSS student handbook** for additional information related to navigating the student portal.

Get a Travel Signature by Submitting a Request for an I-20 Reprint: If you do not have a valid travel signature on your most recent I-20, you can request one from our office by **submitting a request via MyISSS**. Note that our office processing time is ten business days, and once we complete a travel signature request, we will upload a new I-20 onto your account. From there, you can download, print, and sign your document and carry it with you when you travel. Please keep the processing timeline in mind as you plan for your upcoming travel. Note that students need a valid travel signature to re-enter the U.S., but you **do not need it to leave the US**.

Required Documents for Travel: All international students leaving the U.S. need to be in possession of the following upon reentry:

- Valid I-20/DS-2019 with a current travel signature from within the last year (Travel signatures should be valid within six months for students on OPT).
- Valid passport from your home country that is valid more than six months into the future
- Valid U.S. F-1 or J-1 visa stamp in your passport (except for Canadian nationals)
- For students who have an I-20 start date in the past, please use this **letter**. For students who have I-20 start date in Jan. 2022, please use this **letter**.
- SEVIS I-901 fee receipt that matches your current I-20/DS-2019 SEVIS ID number; you can **print a new one here** if needed.
- EAD card and a letter confirming your employment if you are on post-completion OPT.
- COVID-19 vaccination and testing are currently required (see Travel Consideration section above for further information)

Additional Items to Carry with you and Present if Requested:

- Transcripts showing you have been a full-time student and are enrolled for the current or next academic term. If you need to request updated transcripts, you may do so by visiting **USF's Transcripts page** to complete the process for ordering transcripts
- Proof of finances, which can be a bank statement or letter showing that you have funds to cover your stay and tuition while in the U.S.
- Enrollment verification requested from the registrar

Custom and Border Protection (CBP) Search Procedures: When you arrive in the U.S. from any international destination, you may encounter stricter inspection procedures. CBP is legally allowed to search any item you are bringing into the U.S. This includes turning on and asking you to log in to your email, social media, and other items on your laptops and personal devices. You can read more about these search procedures on this **CBP information sheet**. Keep in mind that it is always best to be polite and tell the truth if you are questioned by CBP.

Renewing your U.S. Student Visa: If your student visa (or visa you are studying on) will expire before you plan to return to the U.S., you need to renew it. The visa renewal application is much like the initial visa application and in almost all cases will require you to apply in person and sit for an interview. Please check for visa processing times and book your appointment early. Other information about the visa application process can be found on the **ISSS website** and on the **U.S. State Department website**.

If you need to renew your visa because it is expiring, you will want to make your visa appointment right away. Visa appointments will be limited because of consulate closures in many countries. You should contact your local consulate for more details about when they plan to reopen and when visa appointments will become available. In some cases, a student can request an expedited visa appointment if there is not one available before the next required term. Please keep checking back at **ISSS page** for any visa updates.



OPT Reminders

Reminder that students on OPT are eligible to purchase the USF student health plan per semester for up to one academic year. To determine eligibility, please **submit a request** to voluntarily purchase the USF student health plan. For questions **contact Health Promotion Services**.



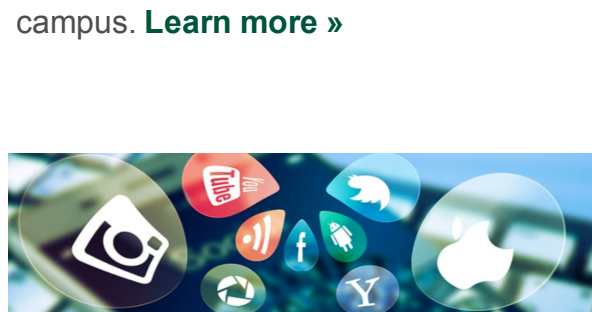
USF Graduation

Requesting a Document from ISSS?

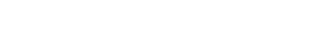
