# Campus Recognized Sorority and Fraternity Transparency Act (AB-524)

The Campus-Recognized Sorority and Fraternity Transparency Act (AB-524; Sections 66310-66312 of California Education Code) requires each institution of higher education to include in the institution's requirements for campus recognition of a campusrecognized sorority or fraternity, as defined, a requirement that the sorority or fraternity submit to the institution on or before July 1, 2023, and annually thereafter, specified information concerning the sorority's or fraternity's members and their conduct.

# USF Campus Resources

## Counseling and Psychological Services (CAPS)

**Brief Therapy, Single Session Therapy:** CAPS offers brief individual therapy and couples therapy through confidential video or phone and in-person to help address your personal and mental health concerns. They also offer single session therapy to get focused help about a specific issue. There's a maximum of 12 individual or couples therapy appointments per academic year, which includes up to 2 single session therapy appointments per semester.

**Consultations:** CAPS provides consultations to USF students about services and resources, regardless of enrollment or location, via video or phone. They also consult with anyone who has concerns about a USF student's mental health and needs advice or resources.

**Crisis Services & All Hours Line:** Students experiencing a mental health crisis will be seen the same day during business hours for crisis stabilization and to be connected with needed resources. During business hours, USF students in crisis or those referring them to CAPS should call (415) 422-6352 to schedule. After hours, students in crisis or needing other immediate mental health support or anyone concerned about the mental health of a USF student can call the CAPS All Hours line at (855) 531-0761. For mental health emergencies involving potential immediate harm to self or others, call USF Public Safety at (414) 422-2911 if on campus, or call 911 if not on campus and ask for a Crisis Intervention Trained (CIT) officer.

**Groups & Workshops:** CAPS offers a variety of therapy groups in fall and spring, most of which meet weekly, for currently enrolled students living in California. They also offer various workshops and workshop series, open to all USF students, regardless of location.

**Mental Health Referrals:** If you need services that CAPS cannot provide, including off-campus mental health services in the Bay Area or elsewhere, CAPS or the Dean of Students Office can provide resources and advice about the process of finding these services.

**Outreach & Education:** CAPS partners with other departments and organizations at USF to provide information about our services and education about various wellness and mental health topics.

## Dean of Students

While Counseling and Psychological Services (CAPS) offers brief, individual, and group therapy to USF students, there are situations in which a student's needs will be best met by mental health services in the community. These include (but are not limited to):

Students who would benefit from long-term therapy

Students seeking regular, weekly counseling appointments

Students seeking psychiatric care and medication management (USF does not have a psychiatrist on staff)

Students who require the care of a specialist (eating disorders, complex trauma, substance abuse, and psychosis)

Students seeking an evaluation

# Appendix

## Glossary

**Campus-recognized sorority or fraternity:** A sorority or fraternity that has officially met the formal chartering and recognition requirements at the institution where it operates.

**Misconduct:** Any conduct in violation of institutional policies reportable under Section 1092(f)(1)(F)(i)(II) and (IX) of Title 20 of the United States Code, as it read on January 1, 2022, or hazing as defined in subdivision (b) of Section 245.6 of the Penal Code.

**Hazing:** Any method of initiation or preinitiation into a student organization or student body, whether or not the organization or body is officially recognized by an educational institution, which is likely to cause serious bodily injury to any former, current, or prospective student of any school, community college, college, university, or other educational institution in this state.

**Sanctioned Events:** Any event in which one of the following occurs:

1. The institution deems the event to be sanctioned by a fraternity or sorority according to their campus policies and practices.
2. The name of a campus-recognized sorority or fraternity or participating sorority or fraternity is used to market or publicize the event.
3. The name of a campus-recognized sorority or fraternity or participating sorority or fraternity is displayed at the event.
4. Official funds of a campus-recognized sorority or fraternity or participating sorority or fraternity are used for the purchase and reimbursement of food, beverages, supplies, venue-related costs, publicity, party rentals, damages or cleanup fees, or any other costs associated with the event.
5. A campus-recognized sorority or fraternity or participating sorority or fraternity, or a benefactor officially affiliated with the sorority or fraternity, receives any portion of funds raised from attendance fees, ticket sales, or other forms of admission fees associated with the event.
