#### Tax Filing for International Students

This week's newsletter includes information to remind you about filing taxes as an international student. As always, if you have any general questions, you can contact our office by **chat**, **phone**, or **email**. If you have specific immigration questions, you can also **make an appointment with your ISSS adviser online**.

## **Filing Taxes**

It's important to be aware that, as a nonresident student in the U.S., you are legally required to file a tax return if you received U.S. income during 2022 (Jan. 1, 2022 – Dec. 31, 2022). Even if you didn't work or receive income in the U.S. in 2022, you're still obliged to file Form 8843 with the IRS. The regular tax filing deadline is April



18. For individuals in California who are impacted by the storms and flooding, the government has extended the deadline. *However, we recommend that students still file by the original deadline to ensure their tax returns are processed as soon as possible.* 

USF has arranged free access to **Sprintax Tax Preparation** for you. Sprintax will guide you through the tax preparation process, arrange the necessary documents, and check if you're due a tax refund or if you owe taxes. On the **ISSS Tax web page** you will find more information about:

- How to determine if you are a resident or non-resident for tax purposes
- What tax forms you may receive and when you will get them
- How to use the Sprintax software to file your tax return or Form 8843 if you had no income

## **Tax Workshops**

Both Sprintax and ISSS will offer tax workshops to help you understand your U.S. tax filing requirements for nonresidents.
